HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on February 23, 2010. Claimant personally appeared with his [REDACTED]

ISSUE

Did the department properly deny claimant's Medicaid (MA)/retro-MA and State Disability Assistance (SDA) application based on a finding he lacks a legally disabling condition?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On February 18, 2009, claimant applied for MA/retro-MA/SDA.

(2) On June 5, 2009, the department's local Medical Review Team (MRT) denied that application; consequently, claimant filed a timely hearing request dated August 29, 2009 (Department Exhibit #1, pgs 1 and 2).

(3) Claimant's hearing was held on February 23, 2010.

(4) At hearing, claimant's attorney provided proof claimant was deemed disabled by the Social Security Administration (SSA) for federal benefit eligibility (RSDI), with onset established as of January 1, 2008 (Client Exhibit A, Fully Favorable Decision).

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In Michigan, the SSA's determination of disability onset is binding for MA eligibility purposes. The same standard is applied in SDA cases. In the present case, evidence of the favorable SSA decision conclusively establishes claimant meets the federal disability standard necessary to qualify for MA/retro-MA/SDA, pursuant to BEM Items 151 and 260.

Claimant's attorney has shown he was determined disabled as of January 2008. Consequently, the department must reverse its erroneous denial and process claimant's disputed application in accordance with departmental policy.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides the department erred in determining claimant is not disabled.

Accordingly, the department's decision is REVERSED, and it is Ordered that:

(1) The department shall approve MA/retro-MA/SDA benefits for claimant if he is otherwise eligible to receive them.

(2) Departmental review of claimant's medical condition is not necessary as long as SSA disability status continues.
