HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on April 26, 2010. Claimant appeared and testified.

<u>ISSUE</u>

Whether the Department of Human Services (DHS or Department) properly determined that Claimant is not "disabled" for purposes of the Medical Assistance (MA-P) program and the State Disability Assistance (SDA) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as a material fact:

- 1. On October 16, 2009, Claimant applied for MA-P and SDA.
- 2. On December 23, 2009, the Medical Review Team denied Claimant's request.
- 3. On February 1, 2010, Claimant submitted to the Department a request for hearing.

- 4. The State Hearing and Review Team (SHRT) denied request.
- 5. Claimant is 28 years old.
- 6. Claimant completed education through special education through 10th grade.
- 7. Claimant has employment experience as a dishwasher, some factory work and as a stocker.
- 8. Claimant's limitations have lasted for 12 months or more.
- 9. Claimant suffers from schizophrenia, mood disorder, traumatic brain injury, arthritis, osteoporosis and panic disorder with agoraphobia.
- Claimant has significant limitations on physical activities involving sitting, standing, walking, bending, lifting, and stooping.
- 11. Claimant has significant limitations on understanding, carrying out, and remembering simple instructions; use of judgment; responding appropriately to supervision, co-workers and usual work situations; and dealing with changes in a routine work setting.
- 12. Claimant's treating physician indicated that Claimant had a GAF of 35-40 and was moderately limited or markedly limited in all areas of the mental residual functional capacity assessment. This same physician indicated that Claimant has difficulty understanding and remaining focused and is limited in social settings.

CONCLUSIONS OF LAW

The Medical Assistance (MA-P) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department administers the MA-P program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The Department conforms to state statute in administering the SDA program.

2000 PA 294, Sec. 604, of the statute states:

- Sec. 604. (1) The department shall operate a state disability assistance program. Except as provided in subsection (3), persons eligible for this program shall include needy citizens of the United States or aliens exempted from the supplemental security income citizenship requirement who are at least 18 years of age or emancipated minors meeting 1 or more of the following requirements:
- (a) A recipient of supplemental security income, social security, or medical assistance due to disability or 65 years of age or older.
- (b) A person with a physical or mental impairment which meets federal supplemental security income disability standards, except that the minimum duration of the disability shall be 90 days. Substance abuse alone is not defined as a basis for eligibility.

Pursuant to Federal Rule 42 CFR 435.540, the Department uses the Federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the MA-P program.

Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905.

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience are reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

Medical evidence may contain medical opinions. Medical opinions are statements from physicians and psychologists or other acceptable medical sources that reflect judgments about the nature and severity of the impairment(s), including symptoms, diagnosis and prognosis, what an individual can do despite impairment(s), and the physical or mental restrictions. 20 CFR 416.927(a)(2).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability. 20 CFR 416.927(e).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence or pace; and ability to tolerate increased mental demands associated with competitive work). 20 CFR, Part 404, Subpart P, Appendix 1, 12.00(C).

Claimant testified to the following symptoms and issues: no feeling in left pinky, arthritis in left hand, chronic back and leg pain, poor memory, poor comprehension, easily frustrated when dealing with others, some anger issues, isolates self, avoids going outside, limps when he walks (due to a steel rod in his leg), can stand for 20 minutes, no physical problems

sitting, can lift up to 15 lbs, limited use of right hand, problems writing, right hand locks up,

sleeps 3 hours at most at night, racing thoughts, can't relax, hears voices, medications make him

drowsy, says he sees shadows, has anxiety attacks at least twice a day, eats sporadically, no

appetite and suicidal thoughts and gets sweaty when nervous. Claimant indicated his condition

even being on medications has gotten worse in the last few months. He is in ongoing therapy.

In this case, this Administrative Law Judge finds that Claimant may be considered

presently disabled at the third step. Claimant appears to meet listing 12.03 or its equivalent.

This Administrative Law Judge will not continue through the remaining steps of the assessment.

Claimant's testimony and the medical documentation support the finding that Claimant meets the

requirements of a listing.

Therefore, Claimant is found to be disabled.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of

law, decides that Claimant is medically disabled as of October 2009.

Accordingly, the Department's decision is hereby REVERSED and the Department is

ORDERED to initiate a review of the application dated October 16, 2009, if not done previously,

to determine Claimant's non-medical eligibility. The Department shall inform Claimant of the

determination in writing. A review of this case shall be set for May 2011.
