HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on March 10, 2010. The claimant personally appeared and provided testimony.

Did the department properly deny the claimant's Food Assistance Program (FAP) application in January, 2010?

FINDINGS OF FACT

ISSUE

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- The claimant submitted an Assistance Application (DHS-1171) on
 January 19, 2010, requesting FAP benefits. (Department Exhibit 4 21).
 - 2. The claimant reported that he was a student attending

to get a Master's degree, with no income. (Department Exhibit 4-21).

- 3. The department denied the claimant's application for FAP benefits on January 20, 2010 because he did not meet the policy criteria for student status.
 - 4. The claimant submitted a hearing request on January 25, 2010.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Department policy indicates that a person considered in "student status" is only eligible for FAP benefits if certain criteria are met. BEM 245. Student status means that the claimant is between ages 18 through 49 and enrolled half-time or more in a college or university. BEM 245. The claimant is in student status as he is 25 years old and currently enrolled half-time or more at Western Michigan University for a Master's degree.

To be eligible to receive FAP benefits while in student status, the claimant must meet one of the criteria listed in department policy. BEM 245. The claimant does not meet any of the criteria to be considered eligible for FAP benefits in student status. The claimant is not receiving FIP; is not in a training program; is not unfit for employment; is not employed and has no dependents. BEM 245. Thus, the department properly denied the claimant's application for FAP benefits.

DECISION AND ORDER

2010-17926/SLK

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the department properly determined the claimant is not eligible to receive FAP benefits and properly denied his application for FAP benefits in January, 2010.

Accordingly, the department's actions are UPHELD. SO ORDERED.
