ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was conducted from Detroit, Michigan on April 29, 2010. Claimant appeared and testified. On behalf of Department of Human Services (DHS), Specialist, and Manager, appeared and testified.

The regulations governing hearing and appeals for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code. MAC R 400.901-.951; it reads in part, "An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by a department action resulting in suspension, reduction, discontinuance, or termination of assistance."

In the present case, DHS admits untimely processing Claimant's redetermination for FAP benefits and erring in calculating Claimant's FAP benefit amount. Prior to the hearing, DHS issued a supplement of FAP benefits which was found to be acceptable to Claimant. Thus, it is

not necessary for the undersigned to decide the matter previously in dispute. Pursuant to MAC R 400.906 and 400.903, Claimant's hearing request is hereby DISMISSED, because Claimant is no longer aggrieved by a DHS action.
