HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9

and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on

May 27, 2010. Claimant appeared and testified. Claimant was represented by

. Following the hearing, the record was kept open for the receipt of additional

medical evidence. Additional documents were received and reviewed.

ISSUE

Did the Department of Human Services (DHS or department) properly determine that

claimant is not "disabled" for purposes of the Medical Assistance (MA-P) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial

evidence on the whole record, finds as material fact:

 On September 25, 2009, an application was filed on claimant's behalf for MA-P benefits. The application requested MA-P retroactive to August of 2009.

- 2) On November 18, 2009, the department denied claimant's application for benefits based upon the belief that claimant did not meet the requisite disability criteria.
- On January 29, 2010, a hearing request was filed to protest the department's determination.
- 4) Claimant, age 48, has a tenth-grade education.
- 5) Claimant last worked in 2007 as a machine operator laying asphalt. Claimant has had no other relevant work experience.
- 6) Claimant has a history of alcohol and nicotine dependence.
- 7) Claimant was hospitalized , as a result of an upper gastrointestinal bleed, anemia, and syncope versus alcohol withdrawal seizure.
- 8) Claimant was re-hospitalized for acute cellulitis of the abdominal wall and ventral incisional hernia.
- 9) Claimant was hospitalized for ventral incisional hernia repair.
- Claimant currently suffers from anemia; peptic ulcer disease; generalized weakness; chronic obstructive pulmonary disease; major depressive disorder, recurrent, severe; social phobia, generalized; generalized anxiety disorder; alcohol dependence, in remission; nicotine dependence; and schizoid personality disorder.
- 11) Claimant has severe limitations upon his ability to walk or stand for long periods of time and lift heavy objects as well as capacities for understanding, carrying out, and remembering simple instructions; use of judgment; responding appropriately

to others; and dealing with change. Claimant's limitations have lasted or are expected to last twelve months or more.

12) Claimant's complaints and allegations concerning his impairments and limitations, when considered in light of all objective medical evidence, as well as the record as a whole, reflect an individual who is so impaired as to be incapable of engaging in any substantial gainful activity on a regular and continuing basis.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Federal regulations require that the department use the same operative definition for "disabled" as used for Supplemental Security Income (SSI) under Title XVI of the Social Security Act. 42 CFR 435.540(a).

"Disability" is:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months ... 20 CFR 416.905

In determining whether an individual is disabled, 20 CFR 416.920 requires the trier of fact to follow a sequential evaluation process by which current work activity, the severity of the impairment(s), residual functional capacity, and vocational factors (i.e., age, education, and work

experience) are assessed in that order. When a determination that an individual is or is not disabled can be made at any step in the sequential evaluation, evaluation under a subsequent step is not necessary.

First, the trier of fact must determine if the individual is working and if the work is substantial gainful activity. 20 CFR 416.920(b). In this case, claimant is not working. Therefore, claimant may not be disqualified for MA at this step in the sequential evaluation process.

Secondly, in order to be considered disabled for purposes of MA, a person must have a severe impairment. 20 CFR 416.920(c). A severe impairment is an impairment which significantly limits an individual's physical or mental ability to perform basic work activities. Basic work activities means the abilities and aptitudes necessary to do most jobs. Examples of these include:

- (1) Physical functions such as walking, standing, sitting, lifting, pushing, pulling, reaching, carrying or handling;
- (2) Capacities for seeing, hearing, and speaking;
- (3) Understanding, carrying out, and remembering simple instructions;
- (4) Use of judgment;
- (5) Responding appropriately to supervision, co-workers and usual work situations; and
- (6) Dealing with changes in a routine work setting. 20 CFR 416.921(b).

The purpose of the second step in the sequential evaluation process is to screen out claims lacking in medical merit. *Higgs v. Bowen* 880 F2d 860, 862 (6th Cir, 1988). As a result, the department may only screen out claims at this level which are "totally groundless" solely

from a medical standpoint. The *Higgs* court used the severity requirement as a "*de minimus* hurdle" in the disability determination. The *de minimus* standard is a provision of a law that allows the court to disregard trifling matters.

In this case, claimant has presented the required medical data and evidence necessary to support a finding that he has significant physical and mental limitations upon his ability to perform basic work activities such as walking and standing for long periods of time and lifting heavy objects; understanding, carrying out, and remembering simple instructions; use of judgment; responding appropriately to supervision, co-workers, and usual work situations; and dealing with changes in a routine work setting. Medical evidence has clearly established that claimant has an impairment (or combination of impairments) that has more than a minimal effect on claimant's work activities. See Social Security Rulings 85-28, 88-13, and 82-63.

In the third step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant's impairment (or combination of impairments) is listed in Appendix 1 of Subpart P of 20 CFR, Part 404. This Administrative Law Judge finds that the claimant's medical record will not support a finding that claimant's impairment(s) is a "listed impairment" or equal to a listed impairment. See Appendix 1 of Subpart P of 20 CFR, Part 404, Part A. Accordingly, claimant cannot be found to be disabled based upon medical evidence alone. 20 CFR 416.920(d).

In the fourth step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant's impairment(s) prevents claimant from doing past relevant work. 20 CFR 416.920(e). It is the finding of this Administrative Law Judge, based upon the medical evidence and objective, physical and psychological findings, that claimant is not capable of the walking, standing, lifting, or personal interaction required by his past employment. Claimant has

presented the required medical data and evidence necessary to support a finding that he is not, at this point, capable of performing such work.

In the fifth step of the sequential consideration of a disability claim, the trier of fact must determine if the claimant's impairment(s) prevents claimant from doing other work. 20 CFR 416.920(f). This determination is based upon the claimant's:

- residual functional capacity defined simply as "what can you still do despite you limitations?" 20 CFR 416.945;
- (2) age, education, and work experience, 20 CFR 416.963-.965; and
- (3) the kinds of work which exist in significant numbers in the national economy which the claimant could perform despite his/her limitations. 20 CFR 416.966.

See *Felton v DSS*, 161 Mich. App 690, 696 (1987). Once claimant reaches Step 5 in the sequential review process, claimant has already established a *prima facie* case of disability. *Richardson v Secretary of Health and Human Services*, 735 F2d 962 (6th Cir, 1984). At that point, the burden of proof is on the state to prove by substantial evidence that the claimant has the residual functional capacity for substantial gainful activity.

In this matter, claimant has a history of alcohol and nicotine dependence. He was hospitalized in **an energy** as a result of upper gastrointestinal bleed, anemia, and syncope versus alcohol withdrawal seizure. He was re-hospitalized in **an energy** for acute cellulitis of the abdominal wall and ventral incisional hernia. In **an energy**, claimant underwent surgical repair of the ventral incisional hernia. On **an energy**, claimant's treating psychiatrist opined that claimant was moderately to markedly limited in nearly every area of understanding and memory, sustained concentration and persistence, social interaction, and adaption. Claimant was seen by a consulting psychologist for the department on

The psychologist diagnosed claimant with major depressive disorder, recurrent, moderate; and social anxiety disorder. The psychologist gave claimant a poor prognosis. On claimant's treating psychiatrist at the diagnosed claimant with major depressive disorder, severe; social phobia, generalized; generalized anxiety disorder; alcohol dependence, in remission; nicotine dependence; and schizoid personality , the treating psychiatrist found claimant to be moderately to disorder. On markedly limited in every area of understanding and memory, sustained concentration and persistence, social interaction, and adaption. On , claimant's treating primary care provider opined that claimant was limited to standing and walking less than two hours in an eight-hour work day and sitting less than six hours in an eight-hour work day. The physician opined that claimant was incapable of operating foot or leg controls with the bilateral lower extremities and incapable of reaching, pushing/pulling, or fine manipulation with the bilateral upper extremities. The treating physician noted limitations with comprehension, memory, sustained concentration, following simple directions, reading and writing, and social interaction.

After careful review of claimant's extensive medical record and the Administrative Law Judge's personal interaction with claimant at the hearing, this Administrative Law Judge finds that claimant's exertional and non-exertional impairments render claimant unable to engage in a full range of even sedentary work activities on a regular and continuing basis. 20 CFR 404, Subpart P, Appendix 11, Section 201.00(h). See Social Security Ruling 83-10; *Wilson v Heckler*, 743 F2d 216 (1986). The department has failed to provide vocational evidence which establishes that claimant has the residual functional capacity for substantial gainful activity and that, given claimant's age, education, and work experience, there are significant numbers of jobs in the national economy which the claimant could perform despite claimant's limitations.

Accordingly, this Administrative Law Judge concludes that claimant is disabled for purposes of the MA program.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that claimant meets the definition of medically disabled under the Medical Assistance program as of August of 2009.

Accordingly, the department is ordered to initiate a review of the September 25, 2009, application, if it has not already done so, to determine if all other non medical eligibility criteria are met. The department shall inform claimant and his authorized representative of its determination in writing. Assuming that claimant is otherwise eligible for program benefits, the department shall review claimant's continued eligibility for program benefits in July of 2011.


