# **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37; upon claimant's request for a hearing to protest the denial of claimant's application for Medical Assistance (MA) and State Disability Assistance (SDA). After due notice, a telephone hearing was held on April 1, 2010. Claimant was represented by

# <u>ISSUE</u>

Whether claimant meets the disability criteria for MA and SDA?

# FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On September 8, 2009, claimant applied for MA-P and SDA with the Michigan Department of Human Services (DHS).
- 2. Claimant applied for 3 months of retro MA.
- 3. On February 8, 2010, MRT denied.
- 4. On February 12, 2010, the department issued notice.

- 5. On February 18, 2010, claimant filed a hearing request.
- 6. On March 15, 2010, SHRT denied claimant.
- 7. At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT), and on August 8, 2011, SHRT issued a decision indicating claimant was approved SSI by SSA.
- 8. Claimant was approved disability benefits by SSA in August, 2010.
- 9. On August 11, 2011, SHRT approved claimant MA and SDA on the basis of claimant's MA and SDA application with the DHS filed on September 8, 2009 including three months of retro MA.

# **CONCLUSIONS OF LAW**

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the SHRT determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability, per PAM, Item 600.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

# **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the MA and SDA programs as of the September 8, 2009 application date, including any retro MA months, if otherwise eligible, and as permitted under policy and procedure.

Accordingly, the department's denial is hereby REVERSED.

The department shall review this case in accordance with its usual policy and procedure.
