## HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After

due notice a telephone hearing was held on October 26, 2009. The Claimant personally appeared and testified.

ISSUE

Did the Department properly close the Claimant's Food Assistance (FAP)?

# FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial

evidence on the whole record, finds as material fact:

- 1. The Claimant was a FAP recipient.
- On July 2, 2009, the department sent the claimant a semi-annual contact report requesting income information. (Department exhibit)
- 3. The claimant made multiple attempts to contact the department seeking assistance.

- 4. On August 12, 2009 the department sent the claimant a notice that his FAP would be closed without the completion of the semi-annual report.
- 5. On August 31, 2009, the department closed the claimant's FAP.
- 6. On September 22, 2009, the Claimant filed a request for a hearing.

#### CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program)

is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal

regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of

Human Services (formerly known as the Family Independence Agency) administers the FAP

program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are

found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and

the Program Reference Manual (PRM).

In the instant case, the Department requested employment information.

At the hearing the claimant testified to having attempted to contact the department

numerous times, seeking assistance, to no avail.

### **Obtaining Verification All Programs**

Tell the client what verification is required, how to obtain it, and the due date (see "Timeliness Standards" in this item). Use the DHS-3503, Verification Checklist, or for MA redeterminations, the DHS-1175, MA Determination Notice, to request verification....

The client must obtain required verification, but you must assist if they need and request help.

If neither the client nor you can obtain verification despite a reasonable effort, use the best available information. If **no** evidence is available, use your best judgment. (PAM 130, p. 2-3).

Here, the requested verifications involved the claimant's employment. I find that the department did not offer assistance to the claimant contrary to the policy cited above. Therefore, the department was in error in closing the claimant's FAP.

### DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department to retroactively reinstate the claimant's FAP and replace any lost benefits if applicable.
