# HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a hearing was held in Warren, Michigan on Monday, April 19, 2010. The Claimant appeared and testified. The Claimant was represented by appeared on behalf of the Department.

During the hearing, the Claimant waived the time period for the issuance of this decision in order to allow for the submission of additional medical evidence. On November 16, 2010, the Authorized Representative faxed a fully favorable Social Security Administration ("SSA") approval with a disability onset date of September 17, 2009. This matter is now before the undersigned for a final decision.

## ISSUE

Whether the Department properly determined that the Claimant was not disabled for purposes of the Medical Assistance ("MA-P") benefit program?

## FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- The Claimant submitted an application for public assistance seeking MA-P benefits on October 6, 2009.
- 2. On December 17, 2009, the Medical Review Team ("MRT") found the Claimant not disabled for purposes of the MA-P benefit program. (Exhibit 1, pp. 1, 2)

- 3. On December 21, 2009, the Department notified the Claimant of the MRT decision. (Exhibit 2)
- 4. On March 16, 2010, the Department received the Claimant's timely written request for hearing. (Exhibit 3)
- 5. On April 1, 2010, the State Hearing Review Team ("SHRT") found the Claimant not disabled. (Exhibit 4)
- 6. At the time of hearing, the Claimant was 38 years old with a date of birth; was 5'7" in height; and weighed 307 pounds.
- 7. On November 16, 2010, the Representative submitted documentation showing that the SSA found the Claimant disabled.

## **CONCLUSIONS OF LAW**

The Medical Assistance ("MA") program is established by Subchapter XIX of Chapter 7 of The Public Health & Welfare Act, 42 USC 1397, and is administered by the Department of Human Services ("DHS"), formerly known as the Family Independence Agency, pursuant to MCL 400.10 *et seq* and MCL 400.105. Department policies are found in the Bridges Administrative Manual ("BAM"), the Bridges Eligibility Manual ("BEM"), and the Bridges Reference Manual ("BRM").

A previously denied MA application is treated as a pending application when MRT determined the Claimant was not disabled and subsequently, the Social Security Administration ("SSA") determines that the Claimant is entitled to SSI based on his disability/blindness for some, or all, of the time covered by the denied MA application provided the Department is informed of the approval within 90 days of the date of the MA denial notice. BEM 260 All eligibility factors must be met for each month MA is authorized. BEM 260

In this case, the SSA approved the Claimant for social security benefits with the disability onset date of September 17, 2009. Accordingly, because of the favorable SSA determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability pursuant to BEM 260.

## **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law finds that the Claimant meets the definition of medically disabled under the MA-P benefit program.

# Accordingly, it is ORDERED:

- 1. The Department shall open (if not previously done so) an ongoing Medical Assistance case for the Claimant based on the October 6, 2009 application.
- 2. The Department shall supplement for any lost benefits that the Claimant was entitled to receive if otherwise eligible qualified.
