### **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9 and MCL 400.37. Claimant's request for a hearing was received on March 22, 2010.

After due notice, a telephone hearing was held on Tuesday, April 27, 2010.

#### **ISSUE**

Whether the Department of Human Services properly determined the Claimant's Food Assistance Program (FAP) eligibility?

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) The Claimant received FAP benefits.
- (2) The Claimant earned two paychecks in February 2010, in the gross amounts of

(3) The Claimant has monthly housing expenses of . Department Exhibit 15.

- (4) The Department completed a FAP budget on March 10, 2010, that determined that the Claimant was entitled to to a monthly FAP allotment of . Department Exhibit 9.
- (5) The Department received the Claimants request for a hearing on March 22, 2010, protesting the amount of her FAP allotment.

#### **CONCLUSIONS OF LAW**

The Food Assistance Program (FAP) (formerly known as the Food Stamp program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or Department), administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), Reference Table Manual (RFT), and the Bridges Reference Manual (BRM).

For FAP purposes, all earned and unearned income available to the Claimant is countable. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be fore than the client actually receives because the gross amount is used prior to any deductions. BEM 500.

The Department determines a client's eligibility for program benefits based on the client's actual income and/or prospective income. Actual income is income that was already

received. Prospective income is income not yet received but expected. Prospective budgeting is the best estimate of the client's future income. BEM 505.

All income is converted to a standard monthly amount. If the client is paid weekly, the Department multiplies the average weekly amount by 4.3. If the client is paid every other week, the Department multiplies the average bi-weekly amount by 2.15. BEM 505.

The Claimant received a total of in earned income. For FAP budgeting purposes, this produces an average bi-weekly income of and a prospective monthly income of when multiplied by 2.15. After applying the 20% earned income deduction, and the standard deduction of the Claimant is left with an adjusted gross income of An excess shelter deduction of is determined by adding the Claimant's shelter expenses to the heat and utility standard under the Low Income Home Energy Assistance Program, and subtracting 50% of her adjusted gross income. However, the Claimant is limited to the shelter maximum.

The Claimant's net income of is determined by subtracting the shelter maximum from her adjusted gross income. A claimant with a group size of one and a net income of entitled to a FAP allotment of which is the amount of FAP benefits granted to the Claimant for this period. RFT 260. I find that the Department has established that it acted in accordance with policy determining Claimant's FAP allotment.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department acted in accordance with policy in computing the Claimant's FAP eligibility.

The Department's FAP eligibility determination is AFFIRMED. It is SO ORDERED.
