HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was conducted from Lansing, Michigan on May 18, 2010.

ISSUE

Whether the Department properly closed Claimant's Adult Medical Program (AMP) case?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant was an AMP recipient.
- (2) The Department completed a new AMP budget to include Claimant's unemployment income which resulted in excess income for AMP. (Exhibits 1-2, 9-11 )

(3) On January 9, 2010, the Department mailed Claimant a Notice of Case Action which informed Claimant that her AMP case would close effective February 1, 2010 due to excess income. (Exhibits 3-7)

(4) On January 13, 2010, the Department received the Claimant's hearing request in regard to the AMP. (Exhibit 8)

### CONCLUSIONS OF LAW

The Adult Medical Program (AMP) is established by Title XXI of the Social Security Act; (1115)(a)(1) of the Social Security Act, and is administered by the Department of Human Services (DHS or department) pursuant to MCL 400.10, *et seq.* Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

All earned and unearned income available to the Claimant is countable. Earned income means income received from another person or organization or from self-employment for duties that were performed for remuneration or profit. Unearned income means ALL income that is not earned and includes FIP, RSDI, SSI and UB. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. BEM 500

The Department determines a client's eligibility for program benefits based on the client's actual income and/or prospective income. Actual income is income that was already received. Prospective income is income not yet received but expected. Prospective budgeting is the best estimate of the client's future income. BEM 505

All income is converted to a standard monthly amount. If the client is paid weekly, the Department multiplies the average weekly amount by 4.3. If the client is paid every other week, the Department multiplies the average bi-weekly amount by 2.15. BEM 505

In the instant case, Claimant reviewed the AMP budgets with the Department and agreed that the Department used the correct income in completing the AMP Budget and did not have any further issue with the Department's determination.

With the above said, based on the testimony and documentation offered at hearing, I find that the Department established that it acted in accordance with policy in closing Claimant's AMP case.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that the Department acted in accordance with policy in closing Claimant's AMP case.

Accordingly, the Department's AMP eligibility determination is AFFIRMED, it is SO ORDERED.
