HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on October 11, 2010. The claimant appeared and testified.

ISSUE

Did the Department properly deny the claimant's Child Care (CDC) application?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On November 6, 2009, the claimant applied for CDC.
- 2. The department sent the claimant a verification checklist requesting various pieces of information.
- 3. On January 29, 2010, the department denied the CDC application due to excess income
- 4. On February 2, 2010, the claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The Child Development and Care program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program

is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department of Human Services (formerly known as the Family Independence Agency) provides services to adults and children pursuant to MCL 400.14(1) and MAC R 400.5001-5015. Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

The department requested various pieces of documentation from the claimant, including documentation of income.

The claimant's group size is (3) three. There is "no DHS assistance if gross monthly income is over \$1,990.00." (RFT 270)

In the instant case the claimant was unable to refute the department's figures concerning her income which was shown to be \$2,124.00. This income is above the income eligibility as provided in RFT 270.

This ALJ finds that the department correctly denied the claimant's CDC.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, AFFIRMS the Department's actions in the instant case.
