HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9;

and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on June 14, 2010.

ISSUE

Did the Department properly award claimant all FAP benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial

evidence on the whole record, finds as material fact:

- (1) Claimant was a FAP recipient.
- (2) Claimant's case was closed in error.
- (3) The Department agreed to supplement claimant for all FAP benefits missed for the month of May, 2010.
- (4) As a result of this agreement claimant, indicated that she no longer wished to proceed with the hearing.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, the Department has agreed that claimant's FAP case closed in error and that claimant's FAP case would be reopened retroactively to May 1, 2010. Claimant would receive all supplemental benefits for that month to which she was otherwise entitled. Claimant agreed to the settlement.

Therefore, as a result of the settlement, it is unnecessary for the Administrative Law Judge to render a decision.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department and the claimant have reached a settlement in the current case.

Therefore, it is unnecessary for the Administrative Law Judge to render a decision.

The Department is ORDERED to reopen claimant's FAP case retroactive to May 1,

2010. Claimant is to be issued all supplemental FAP benefits to which she is otherwise entitled.
