HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, an in-person hearing was held on September 8, 2010.

ISSUE

Whether the Department of Human Services (department) properly determined claimant's eligibility for Medical Assistance (MA).

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. During December 2009, claimant was a recipient of MA benefits. Claimant's assistance was due for financial review. Department Exhibit A, pgs 2-2C.
2. On or about December 7, 2009, the department prepared an MA budget. Total countable income was [REDACTED] consisting of claimant's [REDACTED] benefits, claimant's husband's [REDACTED] benefits, and husband's [REDACTED] payment. A standard [REDACTED] exclusion was included leaving net unearned income [REDACTED]

The Protected Income Level for a household of two living in [REDACTED] is [REDACTED]. Countable MA income of [REDACTED] less Protected Income Level of [REDACTED] leaves a monthly deductible of [REDACTED]. Department Exhibit A, pgs 3-7. Claimant conceded on the record that the income figures were accurate.

3. December 7, 2009, the department sent claimant written notice that she was not eligible for Medicare Savings Program and would have a monthly deductible of [REDACTED]. Department Exhibit A, pgs 8-8E.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

Department manuals provide the following policy statements and instructions for caseworkers:

When determining eligibility for MA, the household's total income must be evaluated. All earned and unearned income of each household member must be included unless specifically excluded. Social Security benefits and pension income are not excluded and must be counted when determining MA eligibility. The MA program provides for a standard \$20 exclusion from unearned income. \$65 plus half of earned income is deducted. A deduction may be included for expenses that enable an impaired or blind person to work and for guardianship or conservatorship fees. An allocation from income may be made to non-SSI children living with the household. Bridges Eligibility Manual (BEM) 500, 541.

Federal regulations at 42 CFR 435.811, .814, .831(C)(I), and .1007 provide standards for MA eligibility. The department, in compliance with these regulations, has prepared income tables that are set forth at Reference Table (RFT) 240 and specify the amount of income a household may have to qualify for MA. These maximum income limits are referred to as the Protected Income Levels (PIL). MA policy provides for additions to the PIL. An addition is allowed if the individual or household must pay health insurance premiums. An addition may be made for the cost of remedial services. BEM 544.

Monthly deductible is a process by which a person or household with excess income may qualify for MA coverage. Meeting a deductible means reporting and verifying allowable medical expenses that equal or exceed the monthly deductible amount for the calendar month being tested. The group must report expenses by the last day of the third month following the month it wants MA coverage. Medical expenses may be allowed when: (a) the expenses are incurred by an MA group member; AND (b) the MA individual or household is responsible for payment, AND (c) when they have not previously been used to meet a monthly deductible. The bills may be old or new expenses. BEM 545.

In this case, the Administrative Law Judge has examined the record and the department policy and finds that the department correctly calculated claimant's countable income and Protected Income Level. A household of two living in [REDACTED] with countable income for MA purposes of [REDACTED] and a Protected Income Level for MA purposes of [REDACTED] has a monthly deductible of [REDACTED]. Therefore, the department's action must be upheld. Finding of Fact 1-3.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides the Department of Human Services acted in compliance with department policy when it determined claimant's eligibility for Medical Assistance benefits.

Accordingly, the department's action is, hereby, UPHELD.
