HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on October 14, 2010.

ISSUE

Was verification noncompliance established?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Negative case action: MA termination on February 20, 2010 based on issue above per BAM 130.
- (2) On February 1, 2010 and February 6, 2010 VCL sent to claimant with a due-back date by February 11, 2010 and February 16, 2010, respectively; it was not received by the DHS.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the client at least 10 days (or other timeframe specified in policy) to obtain the needed information. PAM, Item 105, p. 5.

Claimant testified that he complied with verification requirements by faxing the requested information to the local DHS. But, he doesn't know on what date. Then, he said he also delivered the requested verifications in-person to the DHS. But, again, he doesn't know on what date.

This ALJ finds the DHS testimony that it didn't receive the requested verifications by the due-date more trustworthy than the claimant's testimony that he submitted the verifications, but does not know when.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that verification noncompliance was established.

Accordingly, MA termination UPHELD.
