## ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on October 20, 2010. Claimant's representative appeared and testified.

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, on March 2, 2010, the Claimant's representative requested a hearing, protesting the failure to process an application submitted on January 29, 2009 with a request for retro back to October 2008. During the hearing, the Department

agreed to reprocess the Claimant's application dated January 29, 2009, which include retro MA coverage back to October 2008. The Claimant's representative agreed to this action being taken by the Department.

Since the Department and Claimant have reached an agreement, there is nothing for this Administrative Law Judge to consider, therefore, this case is DISMISSED.
