# **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37; upon claimant's request for a hearing to protest the denial of claimant's application for State Medical Program (SDA). After due notice, an in-person hearing was held on August 10, 2010.

## ISSUE

Whether claimant meets the disability criteria for SDA?

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On November 24, 2009, claimant applied for SDA with the Michigan Department of Human Services (DHS).
- There is no retro MA issue herein.
- 3. On May 17, 2010, MRT denied.
- 4. On May 17, 2010, the department issued notice.
- 5. On May 24, 2010, claimant filed a hearing request.

- 6. On June 21, 2010, SHRT denied claimant.
- 7. Subsequent to the hearing, the Social Security Administration determined that the claimant met the disability criteria for the programs with a disability onset date of December 30, 2008.
- 8. On April 25, 2011, the undersigned Administrative Law Judge received an SOLQ SSA Response Report indicating claimant was approved disability benefits by SSA. Claimant's onset date is identified as December 30, 2008. There are no months left for a substantive review in the case herein.

## **CONCLUSIONS OF LAW**

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

#### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the SDA programs as of the November 24, 2009 application date, if otherwise eligible, and as permitted under policy and procedure.

Accordingly, the department's denial is hereby REVERSED.

The department shall review this case in accordance with its usual policy and procedure.
