HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for hearing on June 5, 2010. After due notice, a telephone hearing was conducted on July 12, 2010 from Detroit, Michigan. The Claimant appeared and testified. Francine Harrison, FIS and Harold Allen, FIM appeared on behalf of the Department.

ISSUE

Whether the Department properly issued a negative action on Claimant's FIP case for a failure to attend Work First?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. Claimant was an active FIP recipient who was referred to JET.
- 2. Claimant was attending Work First in January of 2010. Claimant then testified that she began caring for her boyfriend and father of her children who had suffered a stroke.
- 3. Claimant testified that she submitted medical documentation of the boyfriend's need for care twice to the Department. Claimant further testified that she is a caregiver to her boyfriend and is being paid by the State for his care.
- 4. On 4/1/10, the Department sent Claimant a notice of noncompliance with a 4/13/10 scheduled triage date. (Exhibit 1, p. 1).

- 5. Claimant testified that she did not receive said notice of noncompliance.
- 6. Claimant did not appear for the scheduled triage.
- 7. There was no testimony provided from JET or the Department regarding the specific days that Claimant was noncompliant.
- 8. The Department introduced Exhibit 1, p. 11, titled "Update/View Case Notes" to show that Claimant was noncompliant. However, the Case notes do not contain any notes about which specific days Claimant failed to attend.
- 9. On April 16, 2010, the Department sent Claimant Notice of Case Action. Claimant's FIP case was closed effective 5/1/10. Exhibit 1, p. 4.
- 10. On June 5, 2010, the Department received the Claimant's written hearing request.

CONCLUSIONS OF LAW

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193, 8 USC 601, *et seq.* The Department of Human Services (formerly known as the Family Independence Agency) administers the FIP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3101-3131. The FIP program replaced the Aid to Dependent Children (ADC) program effective October 1, 1996. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables (RFT).

Federal and State laws require each work eligible individual in a FIP group to participate in the Jobs, Education and Training (JET) Program or other employment-related activities unless temporarily deferred or engaged in activities that meet participation requirements. BEM 230A. All work eligible individuals who fail, without good cause, to participate in employment or self-sufficiency-related activities will be penalized. BEM 233A. Failure to appear at a JET program results in noncompliance. <u>Id.</u> A client can request a deferral from Work First. When a request for deferral is not granted, the Department is required to document the basis of the decision for denial and advise the client of their right to discuss the deferral decision with a supervisor and file a grievance if the client disagrees with the activities assigned at JET. BEM 230A, p. 19.

Good cause is a valid reason for noncompliance with employment and/or selfsufficiency related activities that are based on factors that are beyond the control of the noncompliant person. BEM 233A at 4. Good cause includes being physically or mentally unfit for the job or activity as shown by medical evidence or other reliable information. <u>Id.</u> The penalty for noncompliance without good cause is FIP closure. <u>Id.</u> at 6. If good cause is established the negative action is to be deleted. <u>Id.</u> at 12. In this case, the Administrative Law Judge finds that the Department's evidence is insufficient to meet the burden of showing that the Claimant was noncompliant. The Department provided no testimony from the JET workers as to what days Claimant missed from Work First. The Department testified that it was assumed that Claimant did not appear at any time from February 2010 on. Furthermore, ignoring the rules of evidence regarding hearsay and whether the JET notes could even be properly admitted, the JET case notes were also insufficient to identify which days Claimant was noncompliant. Since the regulations provide that good cause is a valid reason for noncompliance, it is necessary to know the dates that Claimant was noncompliant so that Claimant can address good cause for each date, especially when Claimant testified that she had submitted medical documentation regarding providing care to a member of her household. The Department has failed to provide the necessary evidence to show that Claimant was noncompliant.

The undersigned, therefore, finds that the Department has failed to show that Claimant was noncompliant with Work First requirements. Based upon the foregoing facts and relevant law, it is found that the Department's determination is REVERSED.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds the Department's determination is not upheld.

Accordingly, it is ORDERED:

- 1. The Department's closure of Claimant's FIP case is REVERSED.
- 2. The Department's negative action and case closure, effective 5/1/10 for noncompliance for missing Work First, shall be deleted.
- 3. The Department shall supplement the Claimant with any lost benefits she was otherwise entitled to receive.
