

# HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on October 20, 2010. The claimant appeared and testified.

# <u>ISSUE</u>

Did the Department properly close the Claimant's Child Care (CDC)?

## FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The claimant was an ongoing CDC recipient.
- 2. On December 2, 2009, the department closed the claimant's CDC. (Department exhibit 3)
- 3. On December 11, 2009, the department sent the claimant a verification checklist requesting various proofs of income. (Department exhibit 4)
- 4. On March 24, 2010, the Claimant filed a request for a hearing.

## CONCLUSIONS OF LAW

The Child Development and Care program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The

Department of Human Services (formerly known as the Family Independence Agency) provides services to adults and children pursuant to MCL 400.14(1) and MAC R 400.5001-5015. Department policies are contained in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

In the instant case the department closed the claimant's CDC case without being able to testify as to the reason/rationale for closure. The department sent the claimant a verification checklist after closing the claimant's CDC. The department testified that it had reinstated the claimant's CDC in May, 2010.

#### CDC

The client or provider reports, orally or in writing, that a child is no longer in the care of that provider.

The client or provider reports, orally or in writing, a need for fewer authorized hours.

You verify that a child member of the program group was voluntarily placed in foster care.

Information verifies the provider is no longer eligible to receive payments. (BAM 220, p.3).

This ALJ finds that the department was in violation of the department's closure procedures when it closed the claimant's CDC without reason. It should also be noted that the department reinstated the claimant's CDC in April again without reason.

The claimant testified that her CDC provider was not paid for services delivered in December, 2009.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department to reinstate the claimant's CDC as of December 1, 2009, and replace any lost benefits.
