HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on August 25, 2010.

ISSUE

Was non-verification compliance established?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- Negative case action: MA termination on March 19, 2010 based on issue above per BEM 105/210/220.
- (2) On February 9, 2010, VCL mailed to claimant with due-date of March 1, 2010; it was not received.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the client at least 10 days (or other timeframe specified in policy) to obtain the needed information. PAM, Item 105, p. 5.

Responsibility to Report Changes

All Programs

This section applies to all groups **except** most FAP groups with earnings.

Clients must report changes in circumstances that potentially affect eligibility or benefit amount. Changes must be reported **within 10 days**:

- . after the client is aware of them, or
- the start date of employment. PAM, Item 105, p. 7.

The claimant testified that he did not receive the DHS mailing at his last known address because he was in transition to his new address.

The claimant had the responsibility to promptly notify the DHS of his new forwarding address per DHS mailing purposes. This he failed to do.

Therefore, this ALJ is persuaded by the preponderance of the evidence of record that non-verification compliance was established.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that non-verification compliance was established.

Accordingly, MA termination UPHELD.
