HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on December 8, 2010. The claimant personally appeared and was represented by her daughter, who possesses a power of attorney for her mother.

<u>ISSUE</u>

Did the Department properly figure his/her Medical Assistance (MA) deductable?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

1. On July 21, 2010, the Claimant filed a request for a hearing, protesting the deductible down as calculated by the department.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

In the instant case, the claimant questions the Department's calculation of his/her MA.

The undersigned has reviewed the MA budget and found it to be correct. The protected income limit is \$375.00. The claimant's income is \$1,338.00 minus a \$20.00 general exclusion. This equals the \$943.00 deductible.

This ALJ sympathizes with the claimant but there is nothing that can be done to change the above equation.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, AFFIRMS the Department's actions in the instant case.
