HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on February 10, 2011. Claimant appeared and testified.

ISSUE

Whether the Department of Human Services (Department) properly determined that Claimant is not "disabled" for purposes of the Medical Assistance (MA-P) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. On March 26, 2010, Claimant applied for MA-P and retro MA to December 2009.
2. On July 6, 2010, MRT denied Claimant's request.
3. On September 9, 2010, Claimant submitted to the Department a request for hearing.
4. The State Hearing and Review Team denied Claimant's request.
5. Subsequent to the hearing, the Social Security Administration determined that Claimant met the disability criteria for the Retirement and Survivors Disability Insurance (RSDI) program effective October 2009.

CONCLUSIONS OF LAW

MA-P is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department administers MA-P pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).


Because of the Social Security Administration's determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability, per BEM Item 260.

The Department is required to initiate a determination of Claimant's financial eligibility for the requested benefits, if not previously done.

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that Claimant is medically disabled under MA-P as of December 2009.

DECISION AND ORDER

Accordingly, the Department's decision is hereby REVERSED and the Department is ORDERED to open an ongoing MA case for Claimant effective December 2009.
