#### **HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on July 15, 2010.

#### **ISSUE**

Was verification compliance established?

### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- Negative case action: CDC termination on July 20, 2009, based on issue above per PAM 220.
- (2) On June 18, 2009, a recertification request was sent to claimant for a review on July 1, 2009; the verifications were timely submitted except for the disputed complete income verifications for 30 days.

#### CONCLUSIONS OF LAW

The Child Development and Care program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Federal Regulations, Parts 98 and 99. The Department of Human Services (DHS or department) provides services to adults and children pursuant to MCL 400.14(1) and MAC R 400.5001-5015. Department policies are contained in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the client at least 10 days (or other timeframe specified in policy) to obtain the needed information. PAM, Item 105, p. 5.

The claimant testified under oath that she delivered her complete income verification to the "drop-box" and the DHS agreed except for the completed check-stub to cover the 30 day pay requirement.

The DHR representative testified that she was unable to obtain the claimants old file to verify any missing check stubs.

This ALJ finds the testimony under oath by the claimant more trustworthy and reliable then the DHS information, and the completed timely verification was established.

#### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that verification compliance was established.

Accordingly, CDC termination is REVERSED, and reinstatement of benefits within 10 work days ORDERED.
