HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on April 15, 2010. The Claimant appeared personally and testified.

ISSUE

Did the Department properly close the Claimant's Medical Assistance (MA)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. In August, 2009, the department began its redetermination of the claimant's MA.
- On September 2, 2009, the Department ran an MA budget showing the Claimant's income of \$2,700.00. (Department's exhibit1).
- 3. On August 24, 2009, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security

Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department

of Human Services (formerly known as the Family Independence Agency) administers the MA

program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in

the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the

Program Reference Manual (PRM).

The claimant receives unemployment compensation and RSDI benefits in the amount of

\$2,700.00 per month.

Closures

Close an active deductible case when **any** of the following occur:

No one in the group meets **all** nonfinancial eligibility factors.

Countable assets exceed the asset limit.

The group fails to provide needed information or verification. (PEM 545, p.11).

Here, the claimant's net income is above 185% of the poverty level or \$1,670.00 per

month, (RFT 246, p.1) The department was correct in closing the claimant's MA benefits.

This ALJ sympathizes with the claimant but there is nothing that can be done.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of

law, AFFIRMS the Department decisions in this matter.
