## ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on May 17, 2010. Claimant's representative appeared and testified.

Under Program Administrative Manual Item 600, claimants have the right to contest any Department of Human Services' (Department) decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The Department provides an Administrative Hearing to review the decision and determine if it is appropriate. Department policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the claimant's concerns start when the Department receives a hearing request and continue through the day of the hearing.

In the present case, on April 30, 2008, Claimant applied for Medicaid (MA-P) and retro MA-P. The Department denied Claimant's application for failure to provide verifications. During the hearing, the Department agreed to reprocess Claimant's application dated April 30,

2008, for MA-P including retro MA-P back to January of 2008. The Department agreed to process for medical based upon caretaker relative and, if not eligible, process for disability-based MA-P using the medical documentation submitted by Claimant's representative on April 30, 2009, and submit the application to the Medical Review Team for a decision. Claimant's representative agreed to this action being taken by the Department.

Since the Department and Claimant have reached an agreement, there is nothing for this Administrative Law Judge to consider. Therefore, this case is DISMISSED.
