HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was held on February 1, 2010. The Claimant appeared and testified. [REDACTED] ES and [REDACTED] FIM appeared on behalf of the Department.

ISSUE

Was the Department correct in determining Claimant's FAP benefits and did Claimant receive an overissuance?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant was a Food Assistance benefit recipient receiving \$103 per month in benefits. Claimant's benefits were reduced to \$16 per month and a notice of overissuance was sent to the Claimant.

- (2) Claimant requested a hearing on November 22, 2009 contesting the amount of Food Assistance benefits and whether an overissuance had occurred.
- (3) The parties reached an agreement whereby the Department agreed to reinstate FAP benefits back to October 1, 2009 with a benefit amount of \$103 per month. The parties further agreed that no overissuance occurred.

CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp (“FS”) program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (“CFR”). The Department of Human Services (“DHS”), formally known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et seq* and MAC R 400.3001-3015. Departmental policies are found in the Program Administrative Manual (“PAM”), the Program Eligibility Manual (“PEM”), and the Program Reference Manual (“PRM”).

Under Bridges Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client’s concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, the parties reached an agreement whereby the Department agreed to reinstate FAP benefits back to October 1, 2009 with a benefit

amount of \$103 per month. The parties further agreed that no overissuance occurred. Since the Claimant and the Department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Department and Claimant have come to a settlement regarding claimant's request for a hearing. Therefore it is ORDERED that the Department reinstate FAP benefits back to October 1, 2009 with a benefit amount of \$103 per month, in accordance with this settlement agreement. A supplement shall be paid to the Claimant to cover all benefit amounts she is entitled to.
