HEARING DECISION

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9 and MCL 400.37. Claimant's request for a hearing was received on December 10, 2009. After due notice, a telephone hearing was held on Tuesday, April 20, 2010.

ISSUE

Whether the Department of Human Services (Department) properly terminated the Claimant's Food Assistance Program (FAP) and Medical Assistance (MA) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) The Claimant was receiving FAP benefits.
- (2) The Claimant was receiving MA benefits.

(3) The Department sent the Claimant a Verification Checklist on November 24, 2009, with a due date of December 4, 2009. Department Exhibit 1 & 2.

(4) The Department sent the Claimant notice on December 7, 2009, that the Claimant's MA and FAP benefits were being terminated. Department Exhibits 3 & 4.

(5) The Department received the Claimant's request for a hearing on December 10, 2009, protesting the termination of the FAP and MA benefits.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or Department), administers the FAP program pursuant to MCL 400.10, et seq., and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), Reference Table Manual (RFT), and the Bridges Reference Manual (BRM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or Department) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), Reference Table Manual (RFT), and the Bridges Reference Manual (BRM).

Clients must cooperate with the local office in determining initial and ongoing eligibility. This includes the completion of necessary forms. BAM 105, p. 5. Verification means

documentation or other evidence to establish the accuracy of the client's verbal or written statements. BAM 130, p. 1. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. BAM 130, p. 1. The Department uses documents, collateral contacts, or home calls to verify information. BAM 130, p. 1. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. BAM 130, p. 2. When documentation is not available, or clarification is needed, collateral contact may be necessary. BAM 130, p. 2.

The Department sent the Claimant a Verification Checklist on November 24, 2009, with a due date of December 4, 2009. The checklist gave the Claimant notice that she was required to return the required proofs by the due date, and that if she did not the Department would deny her benefits request. The Department testified that it called the Claimant to remind her of the needed verification proofs, but that it did not receive any proofs from the Claimant.

Based on the testimony and documentation offered at the hearing, I find that the Department established that it acted in accordance with policy in terminating the Claimant's FAP and MA benefits for failure to provide the requested verifications.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department acted in accordance with policy in terminating the Claimant's FAP and MA benefits for failure to provide the requested verifications.

The Department's FAP and MA eligibility determination is AFFIRMED, it is SO ORDERED.
