HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on August 24, 2010.

ISSUE

Was verification compliance established?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Negative case action: SDA application on December 1, 2009, denied on February 22, 2010 based on issue above per BAM 130.
- (2) On January 5, 2010, VCL sent to claimant with a due-date of January 15, 2010 which was extended to January 25, 2010 and thereafter to February 5, 2010; VCL was not submitted.

(3) Claimant does not know the date in February, 2010 in which he mailed the VCL information to the DHS.

CONCLUSIONS OF LAW

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (DHS or department) administers the SDA program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the client at least 10 days (or other timeframe specified in policy) to obtain the needed information. PAM, Item 105, p. 5.

This ALJ is not persuaded by the preponderance of the evidence of record that the claimant returned the requested VCL information to the DHS by the due-date.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that a verification compliance was not established.

Accordingly, SDA denial is UPHELD.
