**AMENDED HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on December 17, 2009. The Claimant appeared and testified.

The original decision remains in full force except for where this decision conflicts with the previously issued decision. The final decision and order shall reflect this change.

The record was left open for the Department to obtain both a psychiatric and internist evaluation. The Claimant, however, died prior to attending any examinations.

**ISSUE**

Whether the department properly determined the claimant is not "disabled" for purposes of the Medical Assistance (MA) program?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as a material fact:

1. On April 28, 2009, the Claimant applied for MA-P and retro MA.
2. On June 26, 2009, MRT denied the Claimant's request.
3. On August 25, 2009, the Claimant submitted, to the Department, a request for hearing.
4. The State Hearing Review Team denied the Claimant.
5. The Claimant is 44 years old.
6. The Claimant completed a high school education.
7. The Claimant has employment experience as a bartender, waitress, and cafeteria worker.
8. The Claimant suffers from disc disease, fibromyalgia and bipolar.
9. At the hearing, the Administrative Law Judge ordered the department to schedule an internist and psychological evaluation for the Claimant.
10. The Claimant died prior to attending the requested examinations.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.1 *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Pursuant to Federal Rule 42 CFR 435.540, the Family Independence Agency uses the federal Supplemental Security Income (SSI) policy in determining eligibility for disability under the Medical Assistance program. Under SSI, disability is defined as:

...the inability to do any substantial gainful activity by reason of any medically determinable physical or mental impairment which can be expected to result in death or which has lasted or can be expected to last for a continuous period of not less than 12 months.... 20 CFR 416.905.

A set order is used to determine disability. Current work activity, severity of impairments, residual functional capacity, past work, age, or education and work experience is reviewed. If there is a finding that an individual is disabled or not disabled at any point in the review, there will be no further evaluation. 20 CFR 416.920.

If the impairment or combination of impairments does not significantly limit physical or mental ability to do basic work activities, it is not a severe impairment(s) and disability does not exist. Age, education and work experience will not be considered. 20 CFR 416.920.

Statements about pain or other symptoms do not alone establish disability. There must be medical signs and laboratory findings which demonstrate a medical impairment.... 20 CFR 416.929(a).

In determining disability under the law, the ability to work is measured. An individual's functional capacity for doing basic work activities is evaluated. If an individual has the ability to perform basic work activities without significant limitations, he or she is not considered disabled. 20 CFR 416.994(b)(1)(iv).

Medical findings must allow a determination of (1) the nature and limiting effects of your impairment(s) for any period in question; (2) the probable duration of the impairment; and (3) the residual functional capacity to do work-related physical and mental activities. 20 CFR 416.913(d).

All of the evidence relevant to the claim, including medical opinions, is reviewed and findings are made. 20 CFR 416.927(c).

For mental disorders, severity is assessed in terms of the functional limitations imposed by the impairment. Functional limitations are assessed using the criteria in paragraph (B) of the listings for mental disorders (descriptions of restrictions of activities of daily living, social functioning; concentration, persistence, or pace; and ability to tolerate increased mental demands associated with competitive work).... 20 CFR, Part 404, Subpart P, App. 1, 12.00(C).

The Administrative Law Judge is responsible for making the determination or decision about whether the statutory definition of disability is met. The Administrative Law Judge reviews all medical findings and other evidence that support a medical source's statement of disability.... 20 CFR 416.927(e).

In the present case, the Claimant alleged physical and mental disabilities during the hearing. Additional evidence was deemed necessary in order to determine the extent and severity of Claimant's alleged conditions. This Administrative Law Judge ordered the Department to schedule an appointment for an internist and psychiatrist evaluation of the Claimant. However, the Claimant died prior to attending any appointments. The Death Certificate indicated multiple drug intoxication as the cause of death.


This Administrative Law Judge is unable to make a determination of disability without additional medical evidence. The Claimant has failed to present medical evidence sufficient enough to render a decision. The Claimant has the burden to demonstrate, by medical evidence, their condition is disabling. 20 CFR 416.912

By policy, the Claimant would be eligible for MA coverage for the month of death **only**.

#### DECISION AND ORDER

This Administrative Law Judge, based on the findings of fact and conclusions of law, decides that the claimant is not "disabled".

Accordingly, department's decision in this matter is AFFIRMED.
