HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for hearing. After due notice, a telephone hearing was conducted from Detroit, Michigan on November 23, 2009. The Claimant was present and testified. Walter Smith, ES, appeared on behalf of the Department.

ISSUE

Whether the Department properly closed Claimant's Food Assistance Program ("FAP") case based upon failure to return verification requested?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for FAP assistance on 9/2/09.
2. The Department requested verifications due on 9/14/09.
3. The Department requested further verifications due on 9/29/09.
4. Claimant indicated that he turned in all requested verifications.

5. The Department agreed to reopen and reprocess Claimant's FAP application with the verifications resubmitted by Claimant at the hearing retroactive to the date of application.
6. As a result of this agreement, Claimant indicated that he no longer wished to proceed with a hearing.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, the department has agreed to reopen and reprocess Claimant's FAP case with the verifications resubmitted at the hearing. If the Claimant is due FAP benefits then he will be entitled to receive benefits from the date of application. As a result of this agreement, Claimant indicated he no longer wished to proceed with the hearing. Since the Claimant and the


Department have come to an agreement it is unnecessary for this Administrative Law Judge to make a decision regarding the facts and issues in this case.

DECISION AND ORDER

The Administrative Law Judge, based upon the findings of fact and conclusions of law, finds that the Department and Claimant have come to a settlement regarding claimant's request for a hearing.

Accordingly, it is ORDERED:

1. The Department shall reopen and reprocess Claimant's FAP case with the verifications resubmitted at the hearing from the date of application.
2. The Department shall delete any negative action associated with the 10/8/09 FAP closure and supplement the Claimant for any lost benefits he was otherwise entitled to receive.
