HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, a telephone hearing was held on September 21, 2010.

ISSUE

Was verification non-compliance established?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Negative case action: MA termination on September 18, 2009 based on issue above per BAM 210.
- (2) On July 19, 2009 VCL sent to claimant with a return due-date by August 1, 2009; it was not returned.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Facts above are undisputed.

The client might be unable to answer a question about himself or another person whose circumstances must be known. Allow the client at least 10 days (or other timeframe specified in policy) to obtain the needed information. PAM, Item 105, p. 5.

Claimant testified that she submitted the requested VCL information, but doesn't remember when. Also, there was a log-in-book at the receptionist DHS desk to sign-in after delivery of verifications. She said she did not sign any book.

This ALJ finds by the preponderance of the evidence of record verification noncompliance was established..

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that verification noncompliance was established.

Accordingly, MA termination UPHELD.
