**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing. After due notice, an in-person hearing was held on July 28, 2010. Claimant personally appeared and testified. Claimant was represented at the hearing [REDACTED]

This hearing was originally held by Administrative Law Judge Jay Sexton. Jay Sexton is no longer affiliated with the Michigan Administrative Hearing System Administrative Hearings for the Department of Human Services. This hearing decision was completed by Administrative Law Judge Landis Y. Lain by considering the entire record.

**ISSUE**

Did the Department of Human Services (the department) properly deny claimant's application for Medical Assistance (MA-P) and retroactive Medical Assistance (retro MA-P)?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On December 12, 2009, claimant filed an application for Medical Assistance and Retroactive Medical Assistance benefits.
- (2) On February 21, 2010, the Medical Review Team denied claimant's application stating that claimant's impairment's lack duration.
- (3) On March 12, 2010, the department case worker sent claimant notice that her application was denied.

- (4) On June 11, 2010, claimant filed a request for a hearing to contest the department's negative action.
- (5) On September 23, 2010, the State Hearing Review Team again denied claimant's application stating in its' analysis and decision: the impairment's are medically managed. The claimant retains the capacity to perform at least unskilled medium work that restricts working around unprotected heights and dangerous machinery. The claimant's impairment's do not meet/equal the intent or severity of a Social Security listing. The medical evidence of record indicates that the claimant retains the ability to perform unskilled medium work. This may be consistent with past relevant work. However there is no detailed description of past work to determine this. In lieu of denying benefits as capable of performing past work a denial to other work based on a Vocational Rule will be used. Therefore, based on the claimant's vocational profile of a younger individual, with 14 years of education and an unskilled work history, MA-P is denied using Vocational Rule 203.28 as a guide. Retroactive MA-P was considered in this case and is also denied.
- (6) The hearing was held on July 28, 2010. At the hearing, claimant waived the time periods and requested to submit additional medical information.
- (7) Additional medical information was submitted and sent to the State Hearing Review Team on October 25, 2010.
- (8) On November 10, 2010, the State Hearing Review Team again denied claimant's application stating in its' decision: the claimant's impairment's do not meet/equal the intent or severity of a Social Security listing. The medical evidence of record indicates that the claimant retains the capacity to perform unskilled medium work. This may be consistent with past relevant work. However, there is no detailed description of past work to determine this. In lieu of denying benefits as capable of performing past work a denial to other work based on a vocational rule will be used. Therefore, based on the claimant's vocational profile of a younger individual, 14 years of education and an unskilled work history, MA-P is denied using Vocational Rule 203.28 as a guide. Retroactive MA-P was considered in this case and is also denied.
- (9) On March 12, 2011, claimant received a fully favorable notice of award from Retirement, Survivors and Disability Insurance (RSDI) from the Social Security Administration with a disability onset date of August 25, 2008.

### **CONCLUSIONS OF LAW**

The regulations governing the hearing and appeal process for applicants and recipients of public assistance in Michigan are found in the Michigan Administrative Code, MAC R 400.901-400.951. An opportunity for a hearing shall be granted to an applicant who requests a hearing because his or her claim for assistance has been denied. MAC R 400.903(1). Clients have the right to contest a department decision affecting eligibility or benefit levels whenever it is believed that the decision is incorrect. The department will provide an administrative hearing to review the decision and determine the appropriateness of that decision. BAM 600.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination it is not necessary for the Administrative Law Judge to discuss the issue of disability. BEM, Item 260. The department is required to initiate a determination of claimant's financial eligibility for the requested benefits if not previously done.

### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance and retroactive Medical Assistance benefits as of the December 2, 2009, application date and retroactive Medical Assistance application date.

Accordingly, the department's decision is REVERSED. The department is ORDERED to initiate a review of the Medical Assistance and retroactive Medical Assistance application if it has not already done so to determine if all other non-medical eligibility criteria are met.

The department shall inform the claimant of the determination in writing. The department is also ORDERED to conduct a medical review in July 2012. At that time the department shall determine whether or not the claimant is still eligible to receive RSDI and if not, shall conduct a full medical review.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the mailing of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
