HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on November. The claimant appeared and testified.

ISSUE

Did the Department properly close the Claimant's Medical Assistance (MA) and State Disability Assistance (SDA)?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, finds a material fact:

1. On June 16, 2010, the Department sent the Claimant a notice that her MA and SDA would be cancelled on June 29, 2010.
2. On June 24, 2010, the Claimant filed a request for a hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

The State Disability Assistance (SDA) program which provides financial assistance for disabled persons is established by 2004 PA 344. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, et seq., and MAC R 400.3151-400.3180. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In the instant case, the claimant testified that he has appealed the denial of SSI disability within the time period allotted.

Request an SSI Hearing

An SSI hearing **must** be requested within 60 days of the SSI application denial date You must: (BEM271, p.6).

The department agreed to continue the claimant's MA and SDA if the claimant provides the department with documentation of his having appealed the negative finding by the Social Security Administration (SSA).

The law provides that disposition may be made of a contested case by stipulation or agreed settlement. MCL 24. 278(2). In the instant case, the parties reached an accord. The department agreed to continue the claimant's active MA and SDA provided the claimant provides the department with documentation that he has appealed the negative ruling by the SSA.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that the department and claimant have come to an agreement and **ORDERS** the department to continue the claimant's active MA and SDA provided the claimant provides the department with documentation that he has appealed the negative ruling by the SSA.
