HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37; upon claimant's request for a hearing to protest the denial of claimant's application for MA-P. After due notice, an in-person hearing was held on November 23, 2010. Claimant was represented at the Administrative hearing by [REDACTED].

ISSUE

Whether claimant meets the disability criteria for MA-P?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) On March 5, 2010, claimant applied for MA-P with the Michigan DHS.
- (2) Claimant applied for 3 months of retro MA.
- (3) On May 11, 2010, MRT denied.
- (4) On May 19, 2010, the department issued notice.
- (5) On August 12, 2010, claimant filed a hearing request.
- (6) On August 19, 2010, SHRT denied claimant.

- (7) At the Administrative hearing, claimant's representative presented verification of an SOLQ, SSA Response Reporting indicating claimant was approved disability benefits by SSA. Claimant's onset date is identified as [REDACTED] [REDACTED]. There are no months left for review.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance program as of the March 15, 2010, application date, including any retro MA months if otherwise eligible, and as permitted under policy and procedure.

The department shall review this case in accordance with its usual policy and procedure.
