HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; and MCL 400.37 upon claimant's request for a hearing. After due notice, a hearing was held on January 13, 2011.

ISSUE

Did the claimant receive all MA benefits for which she was entitled?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant was a MA recipient in Wayne County.
- (2) Claimant's son's case was transferred to the MA-L program.
- (3) The Department agreed that claimant's son, [REDACTED] will be taken off of a MA-L case and the Department will contact the SSI coordination unit in Lansing and register claimant for MA-E, retroactive to the date of negative action.

- (4) As a result of this agreement, claimant indicated that she no longer wished to proceed with the hearing.
- (5) Claimant was represented by [REDACTED].

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or Department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM) and Reference Tables (RFT).

Under Bridges Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.


In the present case, the Department agreed that claimant's son, [REDACTED] will be taken off of a MA-L case and the Department will contact the SSI coordination unit in Lansing and register claimant for MA-E, retroactive to the date of negative action. As a result of the agreement, claimant agreed that she no longer wished to proceed with the hearing.

Therefore, as a result of the settlement, it is unnecessary for the Administrative Law Judge to render a decision.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Department and the claimant have reached a settlement in the current case. Therefore, it is unnecessary for the Administrative Law Judge to render a decision.

The Department is ORDERED to transfer claimant's son, [REDACTED] from his current MA-L case; the Department will contact the SSI coordination unit in Lansing and register claimant for MA-E, retroactive to the date of negative action.
