HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a telephone hearing was conducted from ██████████ on January 6, 2010.

ISSUE

Whether the Department made an error in computing Food Assistance Program (FAP) benefits which resulted in an overissuance to Claimant?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant is a FAP recipient.

(2) On August 28, 2009, the Department received a letter from Claimant which stated that Claimant's daughter, [REDACTED], moved out of Claimant's home on August 27, 2009.

(3) On September 2, 2009, the Department removed [REDACTED] from Claimant's case effective October 1, 2009.

(4) On September 2, 2009, the Department mailed Claimant a Notice of Case Action informing her that her FAP benefits had decreased to [REDACTED] effective October 1, 2009. (Exhibit 1)

(5) On October 22, 2009, the Department mailed Claimant a Notice of Overissuance informing her that she was overissued benefits in the amount of [REDACTED] for the month of September 2009. (Exhibit 2)

(6) On October 27, 2009, the Department received Claimant's hearing request regarding the Department's request for repayment of the overissuance.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department), administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Departmental policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Bridges Reference Manual (BRM).

An overissuance is the amount of benefits issued to the client group or CDC provider in excess of what they were eligible to receive. BAM 705, p.5 The amount of the overissuance is the amount of benefits the group or provider actually received minus the amount the group was eligible to receive. BAM 720, p.6 When a client group receives more benefits than they are entitled to receive, DHS must attempt to recoup the overissuance (OI). BAM, p.1

Agency errors are caused by incorrect actions by DHS. BAM 705, p.1 Agency error overissuances are not pursued if the estimated overissuance is less than [REDACTED] per program. BAM 700, p.6 Client errors occur when the customer gave incorrect or incomplete information to the Department. Client errors are not established if the overissuance is less than [REDACTED] unless the client group is active for the overissuance program or the overissuance is a result of a QC audit finding. BAM 700, p. 4, 5

In the instant case, Claimant allegedly received an overissuance of FAP benefits as a result of agency error. The amount in question in this case is [REDACTED] which is clearly below the [REDACTED] threshold set out in Department policy. As such, I do not find that the Department acted in accordance with policy in requesting repayment of an alleged overissuance of FAP benefits to Claimant.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, does not find that the Department acted in accordance with policy in requesting repayment of an alleged overissuance of FAP benefits to Claimant.

Accordingly, the Department's FAP eligibility determination is REVERSED, it is SO ORDERED. The Department shall cease and desist from any further recoupment and issue Claimant supplemental benefits she is entitled to, if any.


