HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; MSA 16.437 upon the Claimant's request for a hearing. After due notice a telephone hearing was held on April 8, 2010. The Claimant was represented by her authorized representative (AR) [REDACTED].

ISSUE

Did the Department properly deny the claimant's Medical Assistance (MA) and retroactive MA application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

1. On March 9, 2009, the claimant, applied for MA and retroactive MA.
2. On April 23, 2009, the department sent the claimant a verification checklist requesting various pieces of information/documents. (Department exhibit 1)

3. The department granted two extensions to the claimant's AR to enable it to provide the requested verifications.
4. On June 1, 2009, the department denied the applications for failure to provide verifications. (Department exhibit 5).
5. On August 28, 2009, the Claimant's AR filed a request for a hearing.

#### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

In the instant case, the claimant's AR contacted the department and requested further time in order to provide the requested documentation.

Effective June 1, 2008

**MA Only**

Allow the client 10 calendar days (or other time limit specified in policy) to provide the verification you request. If the client cannot provide the verification despite a reasonable effort, extend the time limit up to three times. (PAM 130, p.4).

In the instant case the department extended the time limit twice contrary to the policy cited above. Therefore, the department was in error if it denied the claimant's MA and retroactive MA.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the department to reregister the claimant's MA and retroactive applications back to the original application date of March 9, 2009.
