ORDER OF DISMISSAL


This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, a hearing was held on April 5, 2010. Claimant appeared and testified.

Under Program Administrative Manual Item 600, clients have the right to contest any agency decision affecting eligibility or benefit levels whenever they believe the decision is illegal. The agency provides an Administrative Hearing to review the decision and determine if it is appropriate. Agency policy includes procedures to meet the minimal requirements for a fair hearing. Efforts to clarify and resolve the client's concerns start when the agency receives a hearing request and continues through the day of the hearing.

In the present case, on August 20, 2009, the Claimant requested a hearing protesting the closure of her Medicaid (MA) case. During the hearing, the Department agreed to reinstate the Claimant's MA coverage since the Claimant had been approved by the Social Security Administration for RSDI with an onset date of March 2008. The Department agreed to reopen

the Claimant's MA case back to date of closure. The Claimant agreed to this action being taken by the Department.

Since the Department and Claimant have reached an agreement, there is nothing for this Administrative Law Judge to consider, therefore, this case is DISMISSED.
