HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was held on November 1, 2010. The Claimant appeared and testified. [REDACTED], FIM appeared on behalf of the Department.

ISSUE

Was the Department correct in determining Claimant's FAP benefits?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- (1) Claimant was an ongoing recipient of FAP benefits.
- (2) On July 7, 2010 the Department determined that Claimant's FAP benefit would be decreased to \$16 per month from \$342 per month effective September 1, 2010.
- (3) Claimant receives unearned income of \$1013 per month from unemployment benefits.
- (4) Claimant's wife has \$330 per week employment income.
- (5) Claimant has shelter expense of \$1238.

- (6) Claimant requested a hearing on April 26, 2010 contesting the determination of FAP benefits.

CONCLUSIONS OF LAW

The Food Assistance Program, formerly known as the Food Stamp ("FS") program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department of Human Services ("DHS"), formerly known as the Family Independence Agency, administers the FAP program pursuant to MCL 400.10, *et seq* and MAC R 400.3001-3015. Departmental policies are found in the Bridges Administrative Manual ("BAM"), the Bridges Eligibility Manual ("BEM"), and the Program Reference Manual ("PRM").

The federal regulations define household income to include all earned income. 7 CFR 273.9(b). All monthly income must be converted to a nonfluctuating monthly amount. Only 80% of earned income is counted in determining FAP benefits. BEM 550. Under 7 CFR 273.9, as amended, \$132.00 is deducted from the gross income of FAP recipients in determining FAP grants.

In the present case, according to the aforementioned policy on budgeting, Claimant has \$1013 unearned income from unemployment benefits and Claimant's wife has \$1419 earned employment income. Subtracting \$141 from \$2148 results with \$2007 adjusted gross income. Claimant qualified for an excess shelter deduction of \$235 as his shelter expenses \$1280 was in excess of \$1003 (50 percent of \$2007, income after prior deductions were made.) by \$235. Subtracting \$235 from \$2007 results with \$1772 net income. A household of 2 with a net monthly income of \$1772 is entitled to a monthly FAP grant of \$16 per month. RFT 260. Therefore the Department's determination of benefits is correct.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds that the Department properly calculated the Claimant's FAP benefits, and it is ORDERED that the Department's decision in this regard be and is hereby AFFIRMED.
