CONCLUSIONS OF LAW
The Family Independence Pr ogram (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public L aw 104-193, 42 USC 601, et seq. The Department (formerly known as t he Family Independence Agency) administers the FIP program pursuant to MCL 400.10, et seq., and 1997 AACS R 400.3101-31 31. The FIP program replaced the Aid to Depen dent Children (ADC) program effecti ve October 1, 1996. Department polic ies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Reference Tables Manual (RFT).
☐ The Food Assistance Program (FAP) [forme rly known as the Food Stamp (FS) program] is establis hed by the Food St amp Act of 1977, as amend ed, and is implemented by the federal r egulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independenc e Agency) administers the FAP pr ogram pursuant to MCL 400.10, et seq., and 1997 AACS R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Elig ibility Manual (BEM), and the Reference Tables Manual (RFT).
The Medical Assistance (MA) program is es tablished by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).
☐ The State Disability Assistance (SDA) pr ogram which provides financia I assistance for disabled persons is established by 2004 PA 344. The Depart ment (formerly known as the F amily Independence Agency) admini sters the SDA program pursuant to M CL 400.10, et seq., and 1998-2000 AACS R 4 00.3151-400.3180. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RFT).
The Child Development and Care program is established by Titles IVA, IVE and XX of the Social Security Act, the Child Care and Development Block Grant of 1990, and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996. The program is implemented by Title 45 of the Code of Fede ral Regulations, Parts 98 and 99. The Department provides services to adult and children pursuant to MCL 400.14(1) and 1997 AACS R 400.5001-5015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM), and the Reference Tables Manual (RET)
