ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge [REDACTED] by authority of MCL 400.9; and MCL 400.37; upon Claimant's request for a hearing filed on March 10, 2011. After due notice, a hearing was held [REDACTED] Claimant was personally present.

Claimant is requesting a hearing on the issue of her not receiving the notice in time to attend the [REDACTED] orientation. At the time this hearing request was submitted, no negative action had been taken by the department on Claimant's Family Independence Program (FIP) benefits.

MAC 400.903 lays out instances where recipients of assistance have a right to an administrative hearing within the Michigan DHS. This rule specifies when an opportunity for a hearing shall be granted:

An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by an agency action resulting in suspension, reduction, discontinuance, or termination of assistance. MAC 400.903(1).

At the time of Claimant's hearing request, the department had not taken any action to suspend, reduce, discontinue or terminate Claimant's FIP benefits. Under the administrative rule discussed above, Claimant does not have a right to a hearing and thus, this Administrative Law Judge has no jurisdiction in this matter.

Claimant's hearing request is HEREBY DISMISSED for lack of jurisdiction.

NOTICE: Administrative Hearings may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. Administrative Hearings will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
