#### HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing to protest the denial of claimant's application for MA-P. After due notice, an in-person hearing was held on July 12, 2011.

### ISSUE

Whether claimant meets the disability criteria for Medical Assistance (MA)?

## FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1, On August 18, 2010, claimant applied for MA-P with the Michigan Department of Human Services (DHS).
- 2. Claimant did not apply for retro MA.
- 3. On February 28, 2011, MRT denied.
- 4. On November 12, 2010, the department issued notice.
- 5. On January 26, 2011, claimant filed a hearing request.
- 6. On April 12, 2011, SHRT denied claimant.
- At the conclusion of the hearing, the record was held open at claimant's request for the submission of additional medical records. Medical records were received and submitted to the State Hearing Review Team (SHRT), and SHRT issued a decision indicating claimant had been approved Social Security disability. There are no months left to review. .

8. On August 16, 2011, the undersigned Administrative Law Judge received correspondence from SHRT indicating claimant was approved Social Security disability per ALJ in July 2011 with the onset date identified as March 2009.

## **CONCLUSIONS OF LAW**

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, et seq., and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

#### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance program as of the application date, including any retro MA months if otherwise eligible, and as permitted under policy and procedure.

Accordingly, the department's denial is hereby REVERSED.

The department shall review this case in accordance with its usual policy and procedure.
