ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge by authority of MCL 400.9; and MCL 400.37; upon Claimant's request for a hearing filed on March 8, 2011. After due notice, a telephone hearing was held May 5, 2011.

Prior to the closure of the hearing record, Claimant stated she was satisfied with the department's actions and did not want to continue the hearing. Claimant requested the hearing because she believed the department had closed her Food Assistance Program (FAP) case in error. After the department received Claimant's hearing request, it determined Claimant's FAP case was closed in error and it was reinstated.

Therefore, it is not necessary for the Administrative Law Judge to decide the matter that was in dispute. Pursuant to MAC R 400.906 and 400.903, Claimant's hearing request is HEREBY DISMISSED, because Claimant is no longer aggrieved by a department action as it pertains to her FAP benefits.

Administrative Hearings will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 60 days of the filing of the original request.

The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely request for rehearing was made, within 30 days of the receipt date of the rehearing decision.
