**HEARING DECISION**


This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon Claimant's request for a hearing. After due notice, an in-person hearing was held on June 23, 2011. Claimant failed to appear for the hearing. Claimant's representative, [REDACTED], was present at the hearing and consented to the entry of this order regarding a June 1, 2010, application including retro requested back to March 2010 which was denied by MRT on November 16, 2010.

Based upon the record before this Administrative Law Judge, and without any additional evidence or testimony of Claimant to supplement the record and with the consent of the parties, the determination by the Department of Human Services (Department) that Claimant is not "disabled" for purposes of Medicaid is hereby affirmed.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the consent of the parties, affirms the Department's determination that Claimant is not disabled for purposes of eligibility for the Medicaid program.

Accordingly, the Department's decision is hereby UPHELD.
