**DECISION AND ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 42 CFR 431.200 *et seq.*, upon the Appellant's request for a hearing.

After due notice, a hearing was held on [REDACTED]. [REDACTED] the Appellant, appeared on his own behalf. [REDACTED], represented the Department. [REDACTED], appeared as a witness for the Department.

**ISSUE**

Did the Department properly deny the Appellant's request for prior authorization for an upper complete denture?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. The Appellant is a Medicaid beneficiary.
2. On [REDACTED], the Department received a prior authorization request for an upper complete denture from the Appellant's dentist. (Exhibit 1, page 5)
3. On [REDACTED], the Department determined that the Appellant did not qualify under the 5 year rule. The payment history indicated an upper complete denture and a lower partial denture were placed [REDACTED]. (Exhibit 1, pages 5-6).
4. On [REDACTED], the Department sent the Appellant a Notification of Denial. (Exhibit 1, pages 3-4)
5. On [REDACTED], the Appellant's Request for a hearing was received. (Exhibit 1, page 2)

## **CONCLUSIONS OF LAW**

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

### **1.10 PRIOR AUTHORIZATION**

Medicaid requires prior authorization (PA) to cover certain services before those services are rendered to the beneficiary. The purpose of PA is to review the medical need for certain services.

The issue in this case is whether the Department properly applied the five year rule for denture coverage. *MDCH Medicaid Provider Manual, Dental Section, January 1, 2011, pages 17-18*, outlines coverage for dentures:

### **6.6 PROSTHODONTICS (REMOVABLE)**

#### **6.6.A. GENERAL INSTRUCTIONS**

Complete and partial dentures are benefits for all beneficiaries. All dentures require PA. Providers must assess the beneficiary's general oral health and provide a five-year prognosis for the prosthesis requested. An upper partial denture PA request must also include the prognosis of six sound teeth.

Complete or partial dentures are authorized:

- If there is one or more anterior teeth missing;
- If there are less than eight posterior teeth in occlusion (fixed bridges and dentures are to be considered occluding teeth); or
- Where an existing complete or partial denture cannot be made serviceable through repair, relining, adjustment, or duplicating (rebasing) procedures. If a partial denture can be made serviceable, the dentist should provide the needed restorations to maintain use of the existing partial, extract teeth, add teeth to an existing partial, and remove hyperplastic tissue.

Before final impressions are taken and any construction begun on a complete or partial denture, healing adequate to support a prosthesis must take place following the completion of extractions or surgical procedures. This includes the posterior ridges of any immediate denture. An exception is made for the six anterior teeth (cuspid to cuspid) only when an immediate denture is authorized.

Reimbursement for a complete or partial denture includes all necessary adjustments, relines, repairs, and duplications within six months of insertion. This includes such services for an immediate upper denture when authorized.

If a complete or partial denture requires an adjustment, reline, repair, or duplication within six months of insertion, but the services were not provided until after six months of insertion, no additional reimbursement is allowed for these services.

Complete or partial dentures are not authorized when:

- **A previous prosthesis has been provided within five years, whether or not the existing denture was obtained through Medicaid.**
- An adjustment, reline, repair, or duplication will make them serviceable.
- Replacement of a complete or partial denture that has been lost or broken beyond repair is not a benefit within five years, whether or not the existing denture was obtained through Medicaid.

The Department introduced the Appellant's Medicaid beneficiary payment history into evidence showing that a complete upper denture was placed ██████████. (Exhibit 1, page 6) The ██████████ explained that the Appellant's ██████████ prior authorization request for an upper complete denture was denied because the Appellant had this prosthesis provided within the past five years. The Medicaid Utilization Analyst testified that the denial was in accordance with the policy outlined in the Dental Section of the Department's Medicaid Provider Manual.

The Appellant disagrees with the denial and testified that his existing upper complete denture was not made correctly and despite taking it back 10-15 times to be

straightened out it does not do him any good. He stated that his gums are sore and it is hard to sleep at night.

As discussed during the hearing, the Appellant can contact for the investigative section regarding the dentist who provided the upper complete denture in [REDACTED]. The Appellant's complaint would prompt an investigation, which could result recoupment of the money that was paid to the dentist. This would allow the Appellant to obtain authorization for a new provider to make a new upper complete denture. (Medicaid Utilization Analyst Testimony) The Appellant testified that he would call the toll free number after the telephone hearing proceedings concluded.

While this ALJ has sympathy for the Appellant's circumstances, the program parameters do not allow for coverage for dentures more than 1 time in a 5 year period. The Department provided sufficient evidence that its denial was in accordance with policy. If he has not already done so, the Appellant may wish to contact the investigative section to submit a complaint regarding the dentist that provided the existing upper complete denture.

### **DECISION AND ORDER**

The Administrative Law Judge, based on the above findings of fact and conclusions of law, decides that the Department properly denied the Appellant's request for prior authorization for an upper complete denture.

**IT IS THEREFORE ORDERED** that:

The Department's decision is **AFFIRMED**.
