HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the claimant's request for a hearing. After due notice, a telephone hearing was held on January 19, 2011. The Claimant was represented by his Authorized Representative (AR)

<u>ISSUE</u>

Did the Department properly deny the Claimant's Medical Assistance (MA) and retroactive MA?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds a material fact:

- On October 23, 2009, the Claimant applied for MA and retroactive MA.
- 2. On March 29, 2009, the department sent the claimant a notice of a medical exam for April 8, 2010.
- 3. On May 19, 2010, the department sent the claimant a notice that his applications had been denied.
- 4. On June 22, 2010, the claimant's AR filed a request for a hearing.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR).

The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

It should be noted that the department was not in attendance at the hearing. The hearing was scheduled for 8:30 am and the department was called and emailed to begin the hearing with no response.

AUTHORIZED REPRESENTATIVES

All Programs

An **authorized representative** (AR) is a person who applies for assistance on behalf of the client and/or otherwise acts on his behalf (PAM 110, p.7).

In the instant case, the Department failed to send the notice of the medical appointment to the claimant's AR. Therefore, the Department effectively, sent no notice.

DECISION AND ORDER

The Administrative Law Judge based on the above findings of fact and conclusions of law, REVERSES AND ORDERS the Department to reregister the claimant's October 23, 2009, MA and retroactive applications.
