DECISION AND ORDER
This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 42 CFR 431.200 <i>et seq.</i> , upon the Appellant's request for a hearing.
After due notice, a hearing was held on appeared on her own behalf. Appeals Review Officer, represented the Department. Department. Department.
<u>ISSUE</u>
Did the Department properly deny the Appellant's request for prior authorization for a complete upper denture and a lower partial denture?
FINDINGS OF FACT
The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:
The Appellant is a Medicaid beneficiary.
 On, the Department received a prior authorization request for a complete upper denture and a lower partial denture from the Appellant's dentist. (Exhibit 1, page 3)
3. On the Upper complete denture and lower partial denture under the 5 year rule. The Appellant's case history indicated that the Appellant previously received a complete upper denture and lower partial denture on pages 3-4). (Exhibit 1, pages 3-4)
4. On the Department sent a Notification of Denial to the Appellant (Exhibit 1, pages 7-8)

CONCLUSIONS OF LAW

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

1.10 PRIOR AUTHORIZATION

Medicaid requires prior authorization (PA) to cover certain services before those services are rendered to the beneficiary. The purpose of PA is to review the medical need for certain services.

MDCH Medicaid Provider Manual, Practitioner Section, April 1, 2011, page 4.

The issue in this case is whether the Department properly applied the five year rule for denture coverage. *MDCH Medicaid Provider Manual, Dental Section, April 1, 2011, pages 17-18,* outlines coverage for dentures:

6.6 PROSTHODONTICS (REMOVABLE)

6.6.A. GENERAL INSTRUCTIONS

Complete and partial dentures are benefits for all beneficiaries. All dentures require PA. Providers must assess the beneficiary's general oral health and provide a five-year prognosis for the prosthesis requested. An upper partial denture PA request must also include the prognosis of six sound teeth.

Complete or partial dentures are authorized:

- If there is one or more anterior teeth missing;
- If there are less than eight posterior teeth in occlusion (fixed bridges and dentures are to be considered occluding teeth); or
- Where an existing complete or partial denture cannot be made serviceable through repair, relining, adjustment, or duplicating (rebasing) procedures. If a partial denture can be made serviceable, the dentist should provide the needed restorations to maintain

use of the existing partial, extract teeth, add teeth to an existing partial, and remove hyperplastic tissue.

Before final impressions are taken and any construction begun on a complete or partial denture, healing adequate to support a prosthesis must take place following the completion of extractions or surgical procedures. This includes the posterior ridges of any immediate denture. An exception is made for the six anterior teeth (cuspid to cuspid) only when an immediate denture is authorized.

Reimbursement for a complete or partial denture includes all necessary adjustments, relines, repairs, and duplications within six months of insertion. This includes such services for an immediate upper denture when authorized.

If a complete or partial denture requires an adjustment, reline, repair, or duplication within six months of insertion, but the services were not provided until after six months of insertion, no additional reimbursement is allowed for these services.

Complete or partial dentures are not authorized when:

- A previous prosthesis has been provided within five years, whether or not the existing denture was obtained through Medicaid.
- An adjustment, reline, repair, or duplication will make them serviceable.
- Replacement of a complete or partial denture that has been lost or broken beyond repair is not a benefit within five years, whether or not the existing denture was obtained through Medicaid.

Medicaid Provider Manual, Dental Section, Version date April 1, 2010 Pages 17-18. (emphasis added by ALJ)

The Department introduced documentation from the Appellant's Medicaid beneficiary case history into evidence showing that a complete upper denture and a lower partial denture were placed. (Exhibit 1, page 4) The Medicaid Utilization Analyst explained that the Appellant's complete upper denture and lower partial denture was denied because these prostheses had been provided to the Appellant within the past five years. The Medicaid Utilization Analyst testified that the denial was in accordance with the policy outlined in

the Dental Section of the Department's Medicaid Provider Manual.

The Appellant disagrees with the denial and testified that she can not eat and has lost 100 pounds. She stated she drinks Ensure but this is not enough. The Appellant further testified that the existing prostheses do not fit correctly and she went to the hospital a few months ago because of infected lacerations in her mouth.

While this ALJ has sympathy for the Appellant's circumstances, the program parameters do not allow for coverage for dentures more than one time in a five year period. The Appellant's dentist incorrectly marked that the Appellant's existing prostheses were placed in the prior authorization form. (Exhibit 1, page 3) The Medicaid Dental Beneficiary history documents that a complete upper denture and a lower partial denture were placed and a lower partial denture were placed appellant's dentist did not indicate any pertinent dental or medical history on the prior authorization request form. (Exhibit 1, page 3) Accordingly, there was no basis for the Department to consider a medical exception to the 5 year rule when this prior authorization request was reviewed. The Department provided sufficient evidence that its denial was in accordance with policy based on the information available at the time the particle of the prior authorization request was reviewed.

If she has not already done so, the Appellant may wish to have her dentist submit a new prior authorization request indicating the pertinent dental and medical history. The dentist should include documentation from the Appellant's doctor and recent hospital visit.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, decides that the Department properly denied the Appellant's request for prior authorization for a complete upper denture and a lower partial denture.

IT IS THEREFORE ORDERED that:

The Department's decision is AFFIRMED.
