HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9; MSA 16.409 and MCL 400.37; M SA 16.437 upon the claimant's request for a hearing. After due notice a telephone hearing was held from Detroit, Michigan on September 21, 2011. The claimant appeared and testified.

<u>ISSUE</u>

Did the Department of Human Services (Department) properly figure his Medic al Assistance (MA) deductible?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On June 13, 2011, the claimant applied for MA.
- 2. On July 1, 2011, the D epartment determined that the claimant was qualified for MA with a monthly deductible of \$721.00.
- 3. On June 30, 2011, the claimant filed a request for a hearing protesting the deductible amount for his MA.

CONCLUSIONS OF LAW

The Medical Assistance (MA) program is estab lished by Title XIX of the Social Sec urity Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, et seq., and MC L 400.105.

Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

In the instant case, the claimant questions the Department's calculation of his MA.

The undersigned has reviewed the MA budget and found it to be correct. The protected income limit is \$375.00 per month for a group of one in Wayne County. The claimant's countable income is \$1,096.00 per month. This equals the \$721.00 deductible. (RFT 240).

This Administrative Law Judge sympathizes with the claimant but there is nothing that can be done to change the above equation.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, AFFIRMS the Department's actions in the instant case.
