#### HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon claimant's request for a hearing to protest the denial of claimant's application for MA-P. After due notice, an in-person hearing was held on January 26, 2011. Claimant was represented by collecting on behalf of a hospital.

# ISSUE

Whether claimant meets the disability criteria for Medical Assistance (MA)?

## FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

- 1. On June 21, 2010, claimant applied for MA-P with the Michigan Department of Human Services (DHS).
- 2. Claimant did not apply for retro MA.
- 3, On July 16, 2010, MRT denied.
- 4. On July 22, 2010, the department issued notice.
- 5. On October 20, 2010, claimant filed a hearing request.
- 6. On November 23, 2010, SHRT denied claimant.
- 7. On August 1, 2011, SHRT indicated that claimant has been approved Social Security disability benefits with an onset date of August 11, 2009.

8. On August 1, 2011, the undersigned Administrative Law Judge received an SOLQ SSA Response Reporting indicating claimant was approved disability benefits by SSA. Claimant's onset date is identified as August 11, 2009. There are no months left for review.

### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Program Administrative Manual (PAM), the Program Eligibility Manual (PEM) and the Program Reference Manual (PRM).

Because of the Social Security Administration determination, it is not necessary for the Administrative Law Judge to discuss the issue of disability. PEM, Item 260; PEM, Item 261.

The department is required to initiate a determination of claimant's financial eligibility for the requested benefits, if required by DHS policy and procedure.

#### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the claimant meets the definition of medically disabled under the Medical Assistance program as of the June 21, 2010 application date, including any retro MA months if otherwise eligible, and as permitted under policy and procedure.

Accordingly, the department's denial is hereby REVERSED.

The department shall review this case in accordance with its usual policy and procedure.
