HEARING DECISION

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Department of Human Services (department) request for a disqualification hearing. After due notice, a telephone hearing was held on October 25, 2011, at which Respondent did not appear. This matter having been initiated by the department and due notice having been provided to Respondent, the hearing was held in Respondent's absence in accordance with Bridges Administrative Manual, Item 725.

ISSUE

Whether Respondent committed an Intentional Program Violation (IPV) of the Food Assistance Program (FAP), the Family Independence Program (FIP), and the Child Development and Care (CDC) program?

FINDINGS OF FACT

The Administrative Law Judge, based upon the clear and convincing evidence on the whole record, finds as material fact:

1. The department's Office of Inspector General (OIG) filed a hearing request to establish an overissuance of benefits received by Respondent as a result of Respondent having committed an Intentional Program Violation (IPV); the OIG also requested that Respondent be disqualified from receiving program benefits.
2. Respondent completed an application for public assistance on June 5, 2007 (DHS 1171), acknowledging his responsibility to report any changes in his income, resources, or living arrangement to the department within ten days of the change. (Department Exhibits 6-13).
3. On Respondent's application, he stated that his daughter was residing in his home and as such, requested benefits for her. (Department Exhibits 6-13).
4. On his redetermination, Respondent stated that his daughter was still living in his house, but at his interview, he told the department worker that

she had gone back to live with her mother in Texas after the summer. (Department Exhibits 15-22).

5. The department contacted the Respondent's daughter's mother and was informed by her that the child had always lived with her, that she had not left the state of Texas, and that at none of the times in question, did the child ever reside with her father. (Department Exhibit 25).
6. As a result of the Respondent's falsely stating that his daughter was residing in his home, Respondent received an overissuance of FAP benefits in the amount of [REDACTED]0, an overissuance of FIP benefits in the amount of [REDACTED] for the period of June 1, 2007 through December 31, 2007, and an overissuance of CDC benefits in the amount of [REDACTED] for the period of June 1, 2007 through July 31, 2007. (Department Exhibits 32-44).
5. Respondent was clearly instructed and fully aware of the responsibility to report true and accurate information to the department.
6. Respondent has no apparent physical or mental impairment that would limit the understanding or ability to fulfill the income reporting responsibilities.
7. Respondent had not committed any previous intentional program violations.

CONCLUSIONS OF LAW

The Food Assistance Program (FAP) (formerly known as the Food Stamp (FS) program) is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the FAP program pursuant to MCL 400.10, *et seq.*, and MAC R 400.3001-3015. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Program Reference Manual (PRM).

In this case, the department has requested a disqualification hearing to establish an overissuance of benefits as a result of an IPV and the department has asked that the respondent be disqualified from receiving benefits. The department's manuals provide the following relevant policy statements and instructions for department caseworkers.

When a customer client group receives more benefits than they are entitled to receive, the department must attempt to recoup the overissuance. BAM 700. A suspected intentional program violation means an overissuance where:

- the client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and

- the client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- the client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill their reporting responsibilities.

The department suspects an intentional program violation when the client has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing, or preventing reduction of program benefits or eligibility. There must be clear and convincing evidence that the client acted intentionally for this purpose. BAM 720.

The department's Office of Inspector General processes intentional program hearings for overissuances referred to them for investigation. The Office of Inspector General represents the department during the hearing process. The Office of Inspector General requests intentional program hearings for cases when:

- benefit overissuances are not forwarded to the prosecutor.
- prosecution of welfare fraud is declined by the prosecutor for a reason other than lack of evidence, and
 - the total overissuance amount is \$1000 or more, or
 - the total overissuance amount is less than \$1000, and
 - the group has a previous intentional program violation, or
 - the alleged IPV involves FAP trafficking, or
 - the alleged fraud involves concurrent receipt of assistance,
 - the alleged fraud is committed by a state/government employee.

A court or hearing decision that finds a client committed an intentional program violation disqualifies that client from receiving program benefits. A disqualified recipient remains a member of an active group as long as he lives with them. Other eligible group members may continue to receive benefits. BAM 720.

Clients that commit an intentional program violation are disqualified for a standard disqualification period except when a court orders a different period. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a concurrent receipt of benefits. BAM 720. This is the respondent's first intentional program violation.

In this case, Respondent falsely stated that his daughter was residing in his home on his assistance application. The child's mother spoke to a department representative and informed the department that the child had never resided with her father in Michigan since moving to Texas. This Administrative Law Judge therefore finds that the

Respondent received an overissuance of FAP benefits in the amount of \$1,247.00, an overissuance of FIP benefits in the amount of \$451.00 for the period of June 1, 2007 through December 31, 2007, and an overissuance of CDC benefits in the amount of \$470.00 for the period of June 1, 2007 through July 31, 2007 due to his Intentional Program Violation.

DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, finds clear and convincing evidence that the Respondent committed an Intentional Program Violation by falsely stating that his daughter resided with him on his assistance application.

Therefore, it is HEREBY ORDERED that:

1. The Respondent shall reimburse the department for FAP benefits ineligibly received as a result of his Intentional Program Violation in the amount of [REDACTED]
2. The Respondent shall reimburse the department for CDC benefits ineligibly received as a result of his Intentional Program Violation in the amount of [REDACTED]
3. The Respondent shall reimburse the department for FIP benefits ineligibly received as a result of his Intentional Program Violation in the amount of [REDACTED]
4. The Respondent is personally ineligible to participate in the FAP program and the FIP for the period of one year. The disqualification period shall be applied immediately.
