CONSENT ORDER OF DISMISSAL

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on October 25, 2011, in Lansing, Michigan. Participants on behalf of Claimant included Johny Salmo. Participants on behalf of the Department of Human Services (Department) included Lynda Griffenburg.

The Michigan Administrative Code R 400.903(1) provides as follows:

An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by an agency action resulting in suspension, reduction, discontinuance, or termination of assistance.

In this case, on August 9, 2011, the Department

- denied Claimant's application for benefits
- closed Claimant's case for benefits
- reduced Claimant's benefits

Claimant requested a hearing to dispute the Department's action. Shortly after commencement of the hearing, the Department indicated the client did in timely submit

the necessary verification information. The Department agreed to go back and redetermine the Claimant's eligibility for MA and SDA benefits beginning July 31, 2011. Claimant testified he was satisfied with this arrangement and that no other issue was in dispute. Therefore, it is not necessary for me to decide the matter on the merits.

Because of this settlement on the record, I ORDER the Department to:

1. Initiate a redetermination of the Claimant's eligibility for MA and SDA benefits beginning July 31, 2011 and to issue retroactive benefits if otherwise eligible and qualified.

Further, in accordance with 1999 AC, R 400.906 and R 400.903, Claimant's hearing request is hereby **DISMISSED**, because there is no longer any issue in dispute regarding his FAP benefits case.

It is SO ORDERED.
